End of work - de la Montagne Road

The ditch profiling, structural rehabilitation and paving work on de la Montagne Road, which began on October 13, has been completed.

Reminder - snow management

We would like to remind residents that it is prohibited to push snow across the street when clearing your driveway. The snow that accumulates can disrupt visibility, cause icy sections of the road to form, or interfere with water flow. Citizens who contravene By-law 19-RM-04 section 6.2 may be subject to a fine.

Luskville Recreational Park

Council awarded the mandate to Pro-Ballast for the supply of posts and ties for the ball field at the Luskville Recreation Park.

The project is funded by Blue Jays grants and the financial assistance from the Ministry of Education (MESS) and Higher Education. The final phase of this project to install the lighting system and the poles is scheduled for the spring of 2021.

Hiring of a Safety Officer

In order to ensure that firefighters use safe work methods during an intervention, the municipal council hired Mrs. Cheryl Hardwick on October 13th as Captain, acting as Safety Officer within the Pontiac Fire Department.

Deployment of the Transcollines integrated regional passenger transportation development project

The Transcollines transit service between l'Isle-aux-Allumettes and Ottawa on Highway 148 is adding bus route 910 to its service.

This line includes strategic stops at L'Isle-aux-Allumettes, Fort-Coulonge, Campbell's Bay', Shawville, the Municipality of Pontiac, Boulevard des Allumettières and Cégep Gabrielle-Roy.

This route was designed with a special focus on students to support student retention. Route 910 is scheduled to open in January 2021.
