AND RESOLVED THAT Council accepts the proposal of the company Équipe Laurence, totaling \$65,190.82 for professional engineering services - (19-TP-041) plans, specifications and monitoring for the rehabilitation project to repair municipal services on sections of Saint-Andrew and Saint-John Streets.

IT IS ALSO RESOLVED THAT the expense be allocated to budget item 23-050-05-721 and that it be funded by the 2014-2018 Excise Tax Grant Program (TECQ).

FINALLY, IT IS RESOLVED THAT the Council mandates on its behalf, the Mayor or her replacement, and the Acting Director General or her replacement, to sign the contract with the successful supplier.

IT IS ALSO RESOLVED to appoint Mr. Toufik Halladja, municipal officer to enforce the regulations for the duration of his mandate.


