## SIMULTANEITY OF SCHOOL AND MUNICIPAL ELECTIONS

WHEREAS the Ministry of education, recreation and sports held a Forum in February 2008 on the governance of school board democracies during which the Quebec Federation of Municipalities presented a memoir;

WHEREAS by way of follow-up to this forum, the Ministry of education, recreation and sports adopted the draft by-law no. 88, Act modifying the Act on public education and the Act with respect to school elections, notably confirming the election of the school board president to universal suffrage;

WHEREAS to grant such a democratic sitting to school boards is strongly questionable considering the rate of participation of 7.9% at the last school elections in 2007;

WHEREAS in October 2008 the Quebec Federation of Municipalities asked the Minister of education, recreation and sports to proceed with setting up a national issue table on a school-municipal consultation grouping the municipalities, the school boards and the government, in order that the real issues related to territorial education be dealt with in priority, notably the maintenance of regional schools, the offer of quality service to students to encourage success, the taxation and use of equipment and infrastructures in an optimal way, for the benefit of all citizens;

WHEREAS the school board has a sectoral function, education compared to municipalities and MRCs, whose mandates involve an integrated management and planning of the territory as a whole;

WHEREAS article 207.1 of the Act on public education stipulates that: "the school board's mission is also to promote and develop public education on its territory, to ensure quality educational services and the students success in view of obtaining a higher level of schooling and the population's qualification and to contribute, under measures provided for by the law, to the social, cultural and economical development of its region";

WHEREAS Mrs. Michelle Courchesne, Minister of education, recreation and sports, plans to suggest simultaneous school and municipal elections in 2013, and this, without having invited municipalities in the process and above all, without having evaluated the impacts;

WHEREAS with eagerness, the Quebec Federation of Municipalities claims the simultaneity of school and municipal elections under the presumption of increasing school electoral participation and decreasing related costs;

WHEREAS at their last meeting on March 11, 2010, the Quebec Federation of Municipalities board of directors still maintained their opposition to the simultaneity of school and municipal elections as long as, within the present context, the real issues are discussed before non-essential legislative modifications;

WHEREAS on March 17, 2010 the Director general of Quebec elections made public, a notice on the feasibility of simultaneous school and municipal elections to which none of the five proposed scenarios showed a decrease in costs and the increase in electoral participation;
