WHEREAS the Municipality of Pontiac can borrow this amount through a by-law which is only subject to approval by the Ministère des Affaires Municipales et de l'Occupation du Territoire (Minister of Municipal Affairs and Land Occupancy), in compliance with the Act respecting Municipal debts and loans;

ARTICLE 3 REPAYMENT OF THE INTERESTS AND OF THE CAPITAL

To provide for the expenditures incurred in relation with the interests and the repayment of the capital on the annual due date of the loan, it is hereby imposed and will be levied annually during the term of the loan, on all taxable properties mentioned in the articles regarding taxation in by-law 03-03, proportionally with the refinanced amount of this by-law in relation with the (total) refinanced amount.

MUNICIPAL RESOLUTON TO SUPPORT THE APPROACH OF THE MUNICIPALITY OF VAL-DES-MONTS WITH THE MAMOT AND THE CPTAQ AS PART OF A PROJECT FOR THE CONSTRUCTION OF AN ELEMENTARY SCHOOL AT VAL-DES-MONTS

WHEREAS the Municipality of Val-des-Monts has been experiencing a constant demographic growth in the last ten years;

WHEREAS the population growth of the Municipality of Val-Des-Monts has led to a substantial increase of the school clientele;

WHEREAS this steady demographic growth requires the installation of new public equipment and infrastructures, in order to ensure the needs of the Municipality's population are adequately met;

WHEREAS to that effect, the Draveurs School Board must build a new elementary school on the Municipality of Val-des-Monts' territory in order to ensure educational services nearby as soon as September 2016;

WHEREAS since no land meeting the set criteria for the establishment of an elementary school is available within the urbanization perimeter in this area;

WHEREAS the Draveurs School Board has researched and evaluated many locations to build the school and has determined that lot 1 932 466 of the Québec cadaster proves to be the best location;

WHEREAS the choice of lot 1 932 466 has been made after a serious study was conducted by the concerned authorities, a study which takes into account the distribution of the clientele, the services, the roads for school transportation, the soil capacity for such equipment, the capability of the area to manage the waste water, the proximity of emergency services, the minimum impact on the agricultural zone, the overall context of the territorial organization and others;

WHEREAS this research has been unable to identify any suitable and available sites outside the agricultural zone to accommodate this installation;

WHEREAS in the Municipality's opinion, there is no other existing site which would be more suitable or available and where the consequences on the agriculture would be less than that of the coveted site;

WHEREAS the project involves the subdivision of lot 1 932 466, but this lot is already too small to be self-sufficient and viable;

WHEREAS there are no farming facilities in the area that could claim that there is a nuisance of any kind, due to the separating distances applicable to this project;

WHEREAS in the Municipality's opinion, after considering the provisions in sections 12 and 62 of the LPTAAQ and knowing the dynamic of Val-des-Monts' farming community, the project is not liable to harm any farm business in the area;

WHEREAS in the Municipality's opinion, with its knowledge of the dynamic of Val-des-Monts' farming community, it would be wrong to claim that the project, as presented, could break the homogeneity of the community and the farm business;

WHEREAS in the Municipality's opinion, it is not unreasonable, quite the opposite, that a Municipality welcomes an elementary school on its territory intended for students of in given area;

WHEREAS the project is proving to be an important component of the socio-economic conditions, which the CPTAQ can take into account before making a decision;

WHEREAS the requested exclusion has become necessary under article 61.2 of the Law;

WHEREAS after weighing the advantages and disadvantages, the Municipality agrees that the CPTAQ should consider that the refusal of this request would prove to be much more detrimental for the whole population of Val-des-Monts than an authorization could be with respect to the potential farming on this property and in the whole area;

To provide for the expenses committed in relation with the interests and to repay the capital of the annual terms of the loan, with the present by-law, it is imposed and will be levied on an annual basis, during the term of the loan, on all taxable properties on the Municipality's territory, a special tax at a sufficient rate according to their value as shown on the assessment role in effect each year.
- ARTICLE 4. If it happens that the amount of an allocation authorized by the present by-law is higher than the amount actually spent in relation to this allocation, the Council is authorized to use the surplus to pay any other expenditure decreed by the present by-law and for which the allocation would prove to be insufficient.
- ARTICLE 5. The Council will attribute to the loan reduction decreed in the present by-law any contribution or subsidy that could be paid for part or all of the expenditure decreed by the present by-law.

The Council will also attribute to the payment, in part or in total of the debt servicing, any grant payable over several years. The reimbursement term corresponding to the amount of the loan will be automatically adjusted at the time determined for the payment of the loan.

ARTICLE 6. The present by-law will come into force according to the Law.
