- 2. Payment of \$50/hour must be made upon submitting the request, by way of a cheque from the association and made to the order of the Municipality of Pontiac;
- 3. It is mandatory that roads aimed by such a request, be part of the roads identified as « tolerance roads » on the list of roads that will benefit from the financial assistance:
- 4. The director of public works is authorized to have the work done according to the availability of the grader, keeping in mind the weather conditions, work schedules (no overtime) and other conditions that may affect the grading schedule;
- 5. Monies spent to that effect will be receivable for financial assistance purposes granted to associations;
- 6. Associations will be notified in writing of the present procedures and will also be notified that they may also call private contractors and that supporting documents for their expenses to that effect are receivable for financial assistance purposes granted to associations.

- 5. Monies spent to that effect will be receivable for financial assistance purposes granted to associations;
- 6. Associations will be notified in writing of the present procedures and will also be notified that they may also call private contractors and that supporting documents for their expenses to that effect are receivable for financial assistance purposes granted to associations.
