ADOPTION OF THE 2012 BUDGET AND THE LEVYING OF TAXES AND COMPENSATIONS FOR SERVICES IN THE YEAR 2012

METHOD OF PAYMENT

- ARTICLE 3 Method of payment of taxes and compensations provided in the present by-law are as follows:
 - all tax or compensation invoices to which the total does not exceed \$300.00, the invoice must be paid in one instalment on March 1st, 2012
 - 2) all tax or compensation invoices to which the total is or exceeds \$300.00, the debtor has the right to pay the invoice in one or three instalments as follows:

Three equal instalments:

- The first instalment must be paid by March 1st, 2012
- The second instalment must be paid by June 1st, 2012
- The third instalment must be paid by October 1st, 2012
- **ARTICLE 4** Taxes and compensations are payable at the director general's office situated at 2024 Route 148, Pontiac.

INTEREST RATES

- ARTICLE 5 All accounts owing to the municipality bear interest at a rate of THIRTEEN PERCENT (13%) per annum from the deadline at which they must be paid. However, only outstanding amounts on each instalment required bear interest.
- ARTICLE 6 In accordance with article 250.1 of the Act Representing Municipal Taxation, this Council decrees the application of a penalty on tax invoices not exceeding .5% of the outstanding principal for every month following its expiration, up to 5% per annum on due accounts.

CHEQUES WITHOUT FUNDS

When a cheque is remitted to the Municipality and payment is refused by the financial institution, administration fees of TWENTY DOLLARS (\$20.00) will be claimed from the drawer in addition to any interests.

COMING INTO FORCE

ARTICLE 8

The present by-law will come into force on the day of its' publication, in accordance with the law.
