AGREEMENT WITH THE MTQ CONCERNING THE DRAINAGE FOLLOWING REPAIRS ON HIGHWAY 148

WHEREAS repairs to be done by the Quebec Department of Transportation, on highway 148 between Terry-Fox and Maple roads may have a negative impact on the drainage downstream from the project;

WHEREAS the MTQ has committed to conducting an engineering study allowing to mitigate the impact that the work will have on the drainage;

AND RESOLVED THAT the following agreement be approved:

- The MTQ is responsible for conducting an engineering study that will serve to determine, quantify, prioritize and to resolve problem areas (worsened) of the proposed drainage downstream from the project, that is, those having the potential to cause damage to municipal property or infrastructures. This deliverable must include all of the documents necessary for the completion of the work to be carried out by the municipality;
- The municipality is responsible for all related work needed on the municipal drainage network below highway 148 and within the project limits;
- As part of the present agreement, the MTQ promises to pay the following costs:
 - o The total cost of the engineering study;
 - o The total cost of the work related to problem areas (worsened) resulting entirely from the project;
 - o 25% of the cost of the work related to problem areas (worsened) resulting from initial design or construction that proves to be inadequate.

This agreement does not relieve the MTQ of its responsibilities under the Civil Code regarding potential consequences of drainage modifications caused by the present project.

IT IS ALSO RESOLVED that this resolution abrogates the resolutions 15-08-2470 and 15-05-2367.

CONTRACT FOR THE COLLECTION OF RESIDUAL MATERIALS - RELEASE TRANSACTION

WHEREAS following the call for tenders # 14-03, the Municipality of Pontiac awarded the contract for the collection of residual materials to Location Martin-Lalonde for the period beginning June 1, 2014 and ending on May 31, 2018;

WHEREAS both parties disagree regarding the interpretation and the execution of the contract;

WHEREAS aside from the disagreement regarding the interpretation of the contract, unforeseen work has been necessary and will continue to be necessary until the termination of the contract;

WHEREAS both parties wish to prevent a dispute regarding the nature and value of the unforeseen work as well as the interpretation and the execution of the contract;

WHEREAS the municipal Council adopted the resolution # 15-08-2476 in order to support the termination process of the contract for the collection of residual materials and that the said resolution provided a maximum amount for adjustment;

WHEREAS a tentative agreement took place between the Municipality and Location Martin-Lalonde, on December 11, 2015;

WHEREAS both parties wish to confirm in writing the terms and conditions of their agreement, especially regarding the termination of the contract;

WHEREAS the Municipality needs time to review its regulation, to prepare a quote which will meet the needs of the population, it must calculate the allocation of costs in a fair manner and issue a new call for proposals;

WHEREAS this tentative agreement makes it possible to remunerate the contractor for the unforeseen work, to continue collecting the residual materials to the Municipality's satisfaction and to terminate the contract on May 31, 2016;

MANDATE FOR THE CLEANING AND INSPECTION OF THE SEWER LINE NETWORK IN THE QUYON SECTOR – MUTUAL AGREEMENT

WHEREAS it is necessary to complete an intervention plan for our water and sewer networks in order to be entitled to subsidies under the Gas Tax Program and Quebec contribution (TECQ) of \$1.7M for the years 2014-2018;

WHEREAS the mandate for cleaning/inspecting done at the beginning of December, required much more effort than anticipated, this caused by the fact that the network has been poorly maintained since its construction;

WHEREAS in the past, the network has only been cleaned on a short section and that a regular cleanup is necessary in order to avoid blockage and backflow problems;

WHEREAS it is necessary to conduct video inspections and cleaning of our sewer network;

WHEREAS no bids were received to fully carry out this mandate at our last call for tenders in September;

WHEREAS we negotiated with Clear Water Works Inc. and we have agreed to complete a partial inspection program in order to provide a minimum of data to the MAMOT to obtain approval for the intervention plan. This approval will give us access to financial assistance under the TECQ Program;

WHEREAS up to 20% of the amount provided by the TECQ can be used elsewhere on the territory of the Municipality, either for roads or other projects;

WHEREAS the fulfillment of this mandate will provide important data for the analysis of the network's potential, to welcome residential development projects as well as limits to possible transformations to the wastewater treatment network, particularly with respect to the septic sludge treatment capacity, given the network infiltration problems;
