



# ANNUAL REPORT 2021 APPLICATION OF BY-LAW 03-21 RELATING TO CONTRACT MANAGEMENT



#### Introduction

The adoption of Bill 67 in March 2021 called for certain modifications to the contract management by-law. By-law 03-21 was therefore adopted by council in order to take into account the necessary modifications. Two regulatory changes were made, including an addition to section 9 in the context of economic recovery following the pandemic. The municipality is to promote the purchase of goods and services from Quebec, suppliers, insurers and contractors with an establishment in Quebec, for a period of 3 years, up to June 25, 2024, with the objective of contributing to the provinces economic recovery following the pandemic. There was also the addition of article 31 concerning the promotion of the French language. The municipality is to promote the use of the French language and is not required to produce a document in a language other than French within the framework of the application of this by-law.

In accordance with article 938.1.2 of the Municipal Code of Quebec (CMQ), this report highlights the application of by-law 03-21 relating to contractual management with regards to contracts awarded by the Municipality of Pontiac during the year 2021. It describes the contract award processes used as well as the measures taken to promote, as much as possible, the rotation of suppliers or at least competitive bidding. It also allows the administrators of the Municipality of Pontiac to take stock of contract management and to get an idea of the number and types of contracts awarded in 2021.

## Summary of rules for awarding contract as outlined in by-law 05-19 concerning contract management

#### Contracts equal to or less than \$ 24,999

In accordance with the contract management bylaw, contracts equal to or less than \$ 24,999 were awarded by the Municipality of Pontiac by mutual agreement with the exception the ecological study for Bronson-Bryant Road which was done through invitation to tender. The Municipality of Pontiac obtained estimates for all the contracts over \$ 10,000 that have been awarded.

#### Contracts Between \$ 25,000 and \$ 105,700


In 2021, twenty-three contracts between \$25,000 and \$105,700 were awarded by the Municipality of Pontiac. Of these 23 contracts, 11 were awarded through call for tenders by invitation, three by call for tenders on the SEAO website and nine were awarded by mutual agreement.

Each contract was awarded while respecting the principles and measures of rotation, as well as the competition mechanism established by articles 9, 10 and 12 of by-law 03-21 on contract management of the Municipality of Pontiac.

Given the nature of the services requested, and in the event that the offers would be greater than the threshold decreed by the Minister, the calls for tenders for the snow removal of sector A as well as installation of the lighting system at the Luskville recreation park were published on the SEAO website. Ultimately, the offers for these contracts were below the threshold of \$105,700.

The contract for the purchase of the membranes for the water treatment plant was given by mutual agreement to Tall Advanced Separation Systems due to the specialized nature of the items required.

The purchase and installation of the Voilà program was made through PG Solutions, as they already provide the municipality with the software used in our day-to-day operations as well as technical support.



The following list indicates the measures taken to promote supplier rotation or competitive tendering for contracts awarded by mutual agreement:

### Contracts of \$ 105,700 or more

In 2021, three contracts involving an expenditure equal to or greater than the threshold decreed by the Minister were awarded by the Municipality of Pontiac. These were published on the Electronic Call System for Tenders (SEAO) and awarded in accordance with article 935 of the Municipal Code of Quebec.

#### **Conclusion**

This report shows that it is necessary to pay particular attention to contracts with a value between \$25,000 and the threshold decreed by the Minister, because the Act requires that suppliers be rotated and it is not always easy to do so. To continue to improve the measures established, the municipality will bolster its list of suppliers for each type of contract.

Apart from the contract awarding process used, the Municipality must continue to strengthen its checks on the transparency, integrity and impartiality of the process by implementing a system for contracts awarded by mutual agreement.
