Roger Larose, President, notes the quorum and opens the meeting. The meeting starts at 7:32 p.m.





5.3 Mandate to RPGL law firm


WHEREAS RPGL law firm has submitted a service offer dated November 26, 2020, to act as legal advisors for the Municipality of Pontiac;

AND RESOLVED THAT Council hereby grants permission to proceed with the purchase of one hundred (100) hours from RPGL law firm to represent the Municipality of Pontiac as legal counsel in all domains, according to the rates provided in their services for the year 2022.

5.4 Professional services of a group insurance consultant for municipalities and organizations, as part of a group purchase by the UMQ

WHEREAS the Municipality of Pontiac has received a proposal from the *Union des municipalités du Québec (UMQ)* to form, on its behalf and on behalf of several other interested municipalities, a group to retain the professional services of a group insurance consultant for municipalities and organizations, as part of a group purchase by the UMQ;

WHEREAS sections 29.9.1 of the Cities and Towns Act and 14.7.1 of the Municipal Code allow a municipality to enter into such an agreement with the UMQ;

WHEREAS the Municipality of Pontiac wishes to join this group;

WHEREAS, in accordance with the law, the UMQ will proceed with a public call for tenders to award the contract;

WHEREAS the said contracting process is subject to "Bylaw number 26 on the contractual management of the UMQ for its grouping agreements" adopted by the UMQ Administrative Council;


WHEREAS the UMQ issued this call for tenders in March 2022;

THEREFORE, it is moved by Councillor Dr. Jean Amyotte and seconded by Councillor Serge Laforest.

AND RESOLVED THAT the Municipality of Pontiac confirms its adherence to the UMQ group to retain the professional services of a group insurance consultant for municipalities and organizations, as part of a group purchase and entrusts the UMQ with the process leading to the awarding of the contract;

THAT the awarded contract will be for a period of one year, renewable from year to year over a maximum period of five years.

THAT the Municipality of Pontiac undertakes to provide the UMQ, within the set time frame, with the information required for the call for tenders.





THAT the Municipality of Pontiac agrees to respect the terms and conditions of the said contract as if it had contracted directly with the supplier to whom the contract will be awarded.

THAT the Municipality of Pontiac agrees to pay the UMQ a management fee of 1.15% of the total premiums paid by the Municipality.






7.2 Extension of contract 19-TP-003A - garbage and residual material collection



7.6 Sweeping of paved roads - correction





8. URBAN PLANNING AND ZONING

8.1 CPTAQ - 1900 Montagne Road

WHEREAS this application is part of a citizen's approach to the CPTAQ to obtain authorization to use lot #2 683 820 for purposes other than agriculture for a residence already built in 1950 in accordance with section 40 of the Act respecting the protection of agricultural land and agricultural activities in Quebec (R.S.Q., c. P-41.1);





WHEREAS this application consists in authorizing the use of the land in the agricultural zone for purposes other than agriculture, namely residential use;

WHEREAS, in accordance with section 58.2 of the Act respecting the protection of agricultural land and agricultural activities, the present notice sent by the Municipality to the CPATQ is motivated by considering the criteria established in section 62 of the LPTAA;

WHEREAS, according to the soil classification of the Canada Land Inventory, the soil where the house will be built is class 2 X. That is a Class 2 soil that has moderate limitations that reduce the range of crops that can be grown or require the application of ordinary conservation measures;

WHEREAS this authorization will have no impact on the agricultural use of neighbouring lots since a house has been built there since 1950;

WHEREAS this application for authorization is not incompatible with agriculture in the area and does not create any constraints regarding the application of laws and regulations aimed at mitigating the inconveniences related to odours inherent to agricultural activities, since the area has little livestock activity;

WHEREAS the application for authorization is not incompatible with agriculture in the area where it is located and does not create any constraints regarding the application of environmental laws and regulations, particularly for animal production establishments. The closest active farm buildings to the affected areas appear to be approximately 120 metres away;

WHEREAS this is an application for a residence that is already built;


WHEREAS there is a limited amount of vacant land in the Municipality of Pontiac that could be used for residential purposes, outside the permanent agricultural zone and Gatineau Park;

WHEREAS the use is authorized under the zoning bylaw of the Municipality of Pontiac;

THEREFORE, it is moved by Councillor Dr. Jean Amyotte and seconded by Councillor Chantal Allen.

AND RESOLVED THAT Council supports the citizen's application to the CPTAQ to authorize the reconstruction of a residence related to a farm on lot #2 683 820.

8.2 CPTAQ - 1976 Lac-Des-Loups Road

WHEREAS this application consists in authorizing usage for purposes other than agriculture, that is the extension of a sand pit on a land located in an agricultural zone;

WHEREAS in accordance with section 58.2 of the Act respecting the protection of agricultural land and agricultural activities, the present notice sent by the Municipality to the CPATQ is motivated considering the criteria established in section 62 of the LPTAA;

WHEREAS, according to the Canada Land Inventory soil classification, the soil is of class 4 MF. That is a soil with very serious limitations that restrict the range of crops or impose special conservation measures or both;

WHEREAS the authorization that may be granted will have no impact on the potential to use the neighbouring lots for agricultural purposes;

WHEREAS this application for authorization is not incompatible with agriculture in the area and does not create any constraint with regard to the application of laws and regulations aimed at mitigating the inconveniences related to odours inherent to agricultural activities, since the area has few livestock operations;


WHEREAS the application for authorization is not incompatible with the agriculture in the sector where it is located and does not create any constraint with regard to the application of laws and regulations concerning the environment and more specifically for animal production establishments. The closest active farm buildings to the subject parties appear to be approximately 120 metres away;

WHEREAS the use is authorized under the zoning bylaw of the Municipality of Pontiac;

THEREFORE, it is moved by Councillor Dr. Jean Amyotte and seconded by Councillor Serge Laforest.

AND RESOLVED THAT Council supports the citizen's application to the CPTAQ to authorize the expansion of the sand pit.

8.3 Minor variance - 24 Asaret Road

WHEREAS an application for a minor variance was submitted for lot #3 966 406 to regularize the location of the secondary building at 1.86 m from the right-side lot line instead of the required two (2) m in zone 2;

WHEREAS this application for a minor variance also includes the regularization of the location of the enclosed porch at 4.84 m from the left-side lot line instead of the required five (5) m prescribed in said zone;

WHEREAS the Urban Planning Advisory Committee (PAC) has analyzed this application for a minor variance on May 31, 2022, and recommends that Council approve the application for a minor variance to allow the secondary building to be located at 1.86 m from the right-side lot line and reject the application for the enclosed porch;

WHEREAS the municipal administration has received additional information since the PAC meeting;

WHEREAS the construction of the enclosed porch was carried out without a building permit, but at the same time as the construction of the main building and that the owners acted in good faith;

WHEREAS the 0.16-metre encroachment of the porch does not cause any prejudice to the neighbours;

THEREFORE, it is moved by Councillor Dr. Jean Amyotte and seconded by Councillor Serge Laforest.

AND RESOLVED THAT Council accepts the application for a minor variance to locate the building at 1.86 m from the right-side lot line and the application to regularize the enclosed porch at 4.84 m from the left-side lot line.






