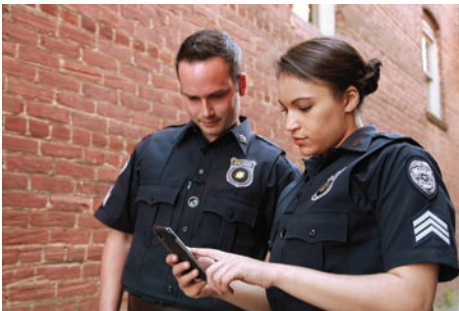

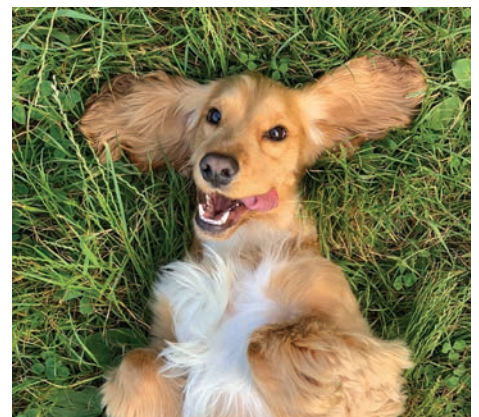
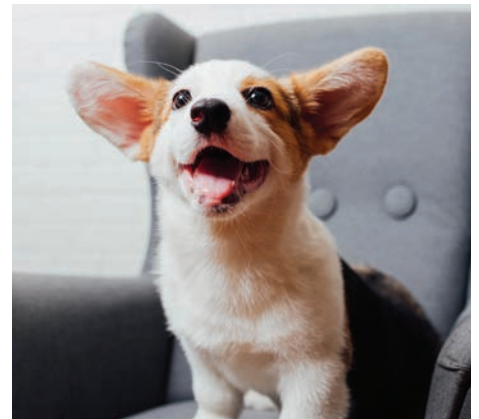

Increase in police surveillance
