Mr. Roger Larose, President, notes the quorum and opens the meeting. The meeting starts at 7:31 p.m.

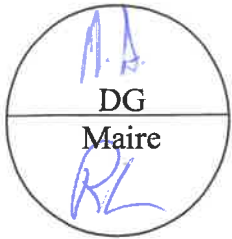
