### **THE FILING OF THE ASSESSMENT ROLE 2024**

**IS HEREBY GIVEN** by the undersigned Assistant Director General of the aforesaid Municipality, that:

The property assessment role of the Municipality of Pontiac to be in force during the fiscal year 2024 has been deposited at my office on August 30, 2023, and that any person may examine it at this place, during regular business hours.

For the 2024 fiscal year of the 2024, 2025 and 2026 property assessment roles of the Municipality of Pontiac, an application for review provided for in Section 1 of Chapter X of the Act respecting municipal taxation, on the grounds that the assessor has not made an amendment that he should have made under article 174 or 174. 2, may be filed at any time during the fiscal year in which an event justifying a change to the roles occurs, or during the following fiscal year if the assessor fails to make such a change.

In accordance with the provisions of section 74.1 of the Act respecting municipal taxation, it is also hereby stated that any person having an interest in this matter may file an application for review of this role, as provided for in section 1 of chapter X of this Act, on the grounds that the assessor has failed to make a change that should have been made under the Act.


To be receivable, an application for review must meet the following conditions:

- be made on the form prescribed for this purpose and available from the M.R.C. des Collines-de-l'Outaouais;
- be accompanied by the sum of money determined by by-law number 196-13 of the M.R.C. des Collines-de-l'Outaouais and applicable to the unit of assessment covered by the request;
- must be filed at the following address or sent there by registered mail:

If the application for review is made by submitting the completed form in person, it is deemed to have been submitted on the day it is received. If it is sent by registered mail, the request is deemed to have been filed on the day it is sent.
