4. PURCHASE OFFER - PICKUP TRUCK FOR PUBLIC SAFETY SERVICES

WHEREAS the Municipality of Pontiac requires a truck for public safety services;

WHEREAS the truck currently in service is out of order due to significant mechanical damage, and there is currently no functional vehicle for this service;

WHEREAS a Quebec Municipality will be holding an auction on February 17, 2025, at which a similar vehicle will be sold;

THEREFORE, it is moved by Councillor Serge Laforest and seconded by Councillor Dr. Jean Amyotte.

AND RESOLVED THAT the Director General be authorized to submit a bid up to a maximum amount of \$16,000, plus applicable fees and taxes, for the purchase of a truck during the auction scheduled for February 17, 2025.

THAT this expense be taken from the reserve fund.


5. PURCHASE OFFER – HEAVY TRUCK FOR PUBLIC WORKS SERVICES

WHEREAS the Municipality has recently purchased three trailers for the Public Works Department;

WHEREAS the Municipality intends to purchase a second heavy truck in anticipation of replacing vehicle 118, which is nearing the end of its service life;

WHEREAS a used truck will be auctioned by Ritchie Bros. Auctions on February 5, 2025;

THEREFORE, it is moved by Councillor Serge Laforest and seconded by Councillor Dr. Jean Amyotte.





AND RESOLVED TO authorize the General Manager to submit a bid up to a maximum of \$25,000, plus applicable fees and taxes, for the purchase of a heavy truck at the auction scheduled for February 5, 2025.

THAT this expenditure be funded from the umbrella borrowing bylaw 03-23.

6. AWARDING OF A TEMPORARY CONTRACT – RECREATION, COMMUNITY LIFE AND COMMUNICATIONS

WHEREAS the position of Recreation, community life and communications Coordinator has been vacant since January 21, 2025;

WHEREAS several urgent matters must be taken care of as soon as possible;

WHEREAS Ms. Goyette has previously worked in this municipal department during an internship and is familiar with certain files;

THEREFORE, it is moved by Councillor Caryl McCann and seconded by Councillor Chantal Allen.

AND RESOLVED THAT the Council of the Municipality of Pontiac grants a temporary contract to Roxanne Goyette for a period of 2 months at 35 hours per week at the rate of \$30 per hour for the management of ongoing files in the Recreation, community life and communications Departement.

THAT the expense be allocated to budget item 02 70100 411.

8. LEASE OF A PRINTER FOR THE QUYON LIBRARY

WHEREAS the Municipality of Pontiac wishes to lease a printer for the Quyon library to meet the needs of its users and municipal administration;

WHEREAS the Municipality already leases a printer from Konica Minolta for the Luskville sector;

WHEREAS the Municipality has received an additional lease offer for a Konica Minolta C3120i printer, including two trays and a bypass, at a cost of \$34.71 per month for a term of five (5) years, with minimum service fees of \$3.31 per month and printing costs of \$0.015 per black-and-white copy and \$0.10 per color copy;

THEREFORE, it is moved by Councillor Caryl McCann and seconded by Councillor Garry Dagenais.

AND RESOLVED THAT the Municipality of Pontiac proceed with the lease of a Konica Minolta C3120i printer for the Quyon library under the terms mentioned above.

THAT the leasing and usage costs be charged to budget item 02 70231 331.
