

## PUBLIC NOTICE

PUBLIC NOTICE IS GIVEN TO PERSONS OF LEGAL CAPACITY TO VOTE AND ENTITLED TO BE REGISTERED ON THE REFERENDUM LIST OF THE MUNICIPALITY

1. During a Council meeting held on April 8, 2025, the Municipal Council of Pontiac has adopted bylaw No. 04-25 entitled: « **ADOPTION OF UMBRELLA BORROWING BYLAW 04-25 DECREERING AN EXPENDITURE AND A LOAN OF \$750,000.00 FOR THE PURCHASE OF VEHICLES AND EQUIPMENT FOR THE PUBLIC WORKS DEPARTMENT** ».
2. Eligible voters who are entitled to be registered on the Municipality's referendum list may request that bylaw No. 04-25 be made the subject of a referendum vote by entering their name, address and status and by signing a register for that purpose.  
Eligible voters wishing to register their name must show some identification such as their health card, driver's licence, passport, Certificate of Indian Status or Canadian Forces identification card.
3. The register will be accessible **from 9:00 a.m. to 7:00 p.m. on April 23, 2025**, at the office of the Municipality of Pontiac, located at 2024 Route 148, Pontiac.
4. The number of applications required for a referendum vote on bylaw number 04-25 is **471**. If this number is not reached, bylaw number 04-25 will be deemed to be approved by those eligible to vote.
5. The result of the registration process will be announced at 9:30 a.m. on April 24, 2025, at Pontiac Town Hall located at 2024 Route 148, Pontiac.

Requirements to be a qualified voter entitled to be included on the Municipality-wide referendum list:

7. Anyone who, on **April 8, 2025**, has not been incapacitated to vote, under section 524 of the Municipal Elections and Referendums Act and meets the following conditions:
  - ☞ be a natural person domiciled in the Municipality of Pontiac and have been domiciled for at least 6 months in Quebec and;
  - ☞ be of legal age and a Canadian citizen and not under legal guardianship.
8. Any sole owner of a property or sole occupant of a business establishment who has not been incapacitated to vote and meets the following conditions:

- ☞ be the owner of a building or sole occupant of a business establishment located in the Municipality of Pontiac for at least 12 months;
  - ☞ in the case of an individual, be of legal age and a Canadian citizen and not under legal guardianship.
9. Any undivided co-owner of an immovable or co-occupant of a business establishment who is not disqualified from voting and meets the following conditions:
- ☞ be an undivided co-owner of a building or co-occupant of a business establishment located in the Municipality of Pontiac, for at least 12 months;
  - ☞ be designated, by means of a power of attorney signed by the majority of the persons who have been co-owners or occupants for at least 12 months, as the person entitled to sign the register on their behalf and to be entered on the referendum list, if applicable. This power of attorney must have been produced before or at the time of signing the register.
10. Legal entity
- ☞ have designated by resolution, from among its members, directors or employees, a person who, on **April 8, 2025**, and at the time of exercising such right, is of full age and a Canadian citizen, who is not under legal guardianship and is not incapacitated to vote by law.
