2. Nomination papers must be filed at the office of the returning officer, secretary or the assistant on the following days and times.

Important: on Friday, October 3, 2025, the office will be open continuously from 9 a.m. to 4:30 p.m.

3. If more than one person wishes to be a candidate for the same seat, you may exercise your voting right by going to your assigned polling station on the following dates and times.

Polling day: Sunday, November 2, 2025, from 10 a.m. to 8 p.m.

Advance polling day: Sunday, October 26, 2025, from noon to 8 p.m.

If you are unable to move about for health reasons and are registered on the list of electors as a domiciled person, you may ask your returning officer until October 15, 2025, to vote in your room located in a recognized health care facility or in your home. The same applies to your caregiver.

4. You can vote by mail if your domicile is not located in the territory of the municipality.

To vote by mail, you must send a written application to the returning officer no later than October 15, 2025.

The mail-in ballot papers will be sent as of October 22, 2025.

If you are registered to vote by mail and have not received your ballot papers on October 27, 2025, you can contact the returning officer to obtain new ones.

Ballot papers must be received at the office of the returning officer no later than Friday, October 31, 2025, at 4:30 p.m.
