INTRODUCTION


It is now possible to add your tax account to your citizen account in just a few steps! In addition, you can also subscribe to receive your tax account online for the following year.

1. OPENING A SESSION ON VOILÀ! WEB PLATFORM

Voilà! is a **personalized platform for citizens** that facilitates communication between citizens and cities.

In order to access your **Citizen account**, you must first log in to the city of your choice.

Enter your login information.

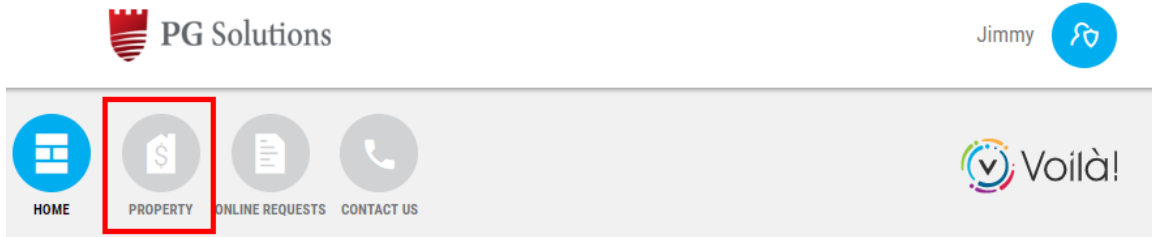

You can, among others, view your tax accounts

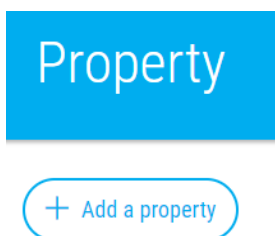

2. ADDING ONE PROPERTY OR SEVERAL PROPERTIES

To add a property to your profile, you will need your tax account for the current year in paper format.

You must first click on **Add a property**.

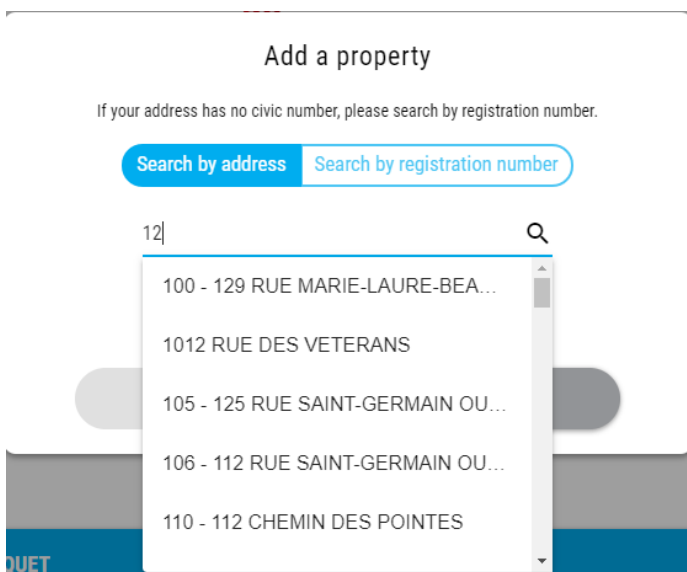


Search for the property by address or by registration number.

Input the civic number of the address or the first digits of the registration number.

Select the address or registration number suggested by the system, then click on **Confirm**.

Search by address or registration number




3. ADDING A TAX ACCOUNT


